- **Falsification**: altering or fabricating any information or citation in an academic exercise or activity.
- Plagiarism: representing, by paraphrase or direct quotation, the published or unpublished work of another person as one's own in any academic exercise or activity without full and clear acknowledgment. It also includes using materials

prepared by another person or by an agency engaged in the sale of term papers or other academic materials.

### **Emergency Procedures**
