

## ITLS 4210 – Fall 2023 Syllabus

### Course Description

This course provides students with the basic skills needed to develop a virtual environment. This is a tool class that uses Unity as the main software for developing environments. This course will be divided into two sections, environment design, and environment programming. Although programming is essential during the process, the course will be programming minimal and suitable for those who are not familiar with programming.

### Course Objectives

By the end of this course, you will be able to:

- 1- explore major concepts in designing, creating environments.
- 2- explore available software and engines of VEs.
- 3- navigate the Unity engine.
- 4- create terrains and environment objects in Unity.
- 5- use and build functional characters in Unity.
- 6- explore the basics of scripting in Unity.
- 7- build UI elements in Unity.

## **Evaluation Methods and Criteria**

### **Weekly Mini projects (10X30)**

On Monday of each week, I will post instructions for the mini-project. Mini projects aim to test your skills you learn during the corresponding week. the mini-project will be due by the following Tuesday.

### **Online Attendance (14 X 10) (Through weekly discussions).**

Online attendance is the percentage of completing all the materials posted each week. Canvas tracks students' progress and records their completion of the learning modules. Reading/watching all the assigned materials during the assigned period is mandatory to get the attendance points. Late/no attendance has a specific policy. You can find this policy below.

There will be a weekly self-reflection forum for you to use. by the end of your assignment, you are going to reflect on your week's activities. This shouldn't be formal. In few sentences, you will write a self-reflection mentioning what you learned and what concerns you have during the week. If you have any specific requests for me, please mention it in your self-reflection and I will make sure I answer any request you have.

### **Final Project (210)**

The final project will include most of the skills learned during the semester. Instructions on the final project will be posted around the middle of the semester.

## Attendance and Excused Absences Policy

All students are expected to read/watch/listen to all the posted materials. This is mandatory. Students are permitted a maximum of two unexcused absences. Missing a module will result in the loss of 10 points from the student's final grade. You are expected to complete the online readings on time and submitting assignments by their due dates. As for the excused absence, you should email a written excuse to your instructor to be considered excused. Not all excuses will be accepted. Acceptable excuses will be determined by the instructor according to the situation. Circumstances that will grant an excused absence are shown below. If the excuse is accepted, the student is still expected to complete their readings/ assignments when they are back from the excused absence.

Late assignments are also unacceptable. A late assignment without an excuse will lead to a zero grade on the assignment. However, submission on time and resubmission after getting the instructor's feedback is allowed and can result in regaining some lost points of the original submission.

*Circumstances that grant excused absences:*

- Illness that prevents online attendance. The student must have documentation from the health center or another physician that indicates the student cannot or should not attend class. Health center documentation is not acceptable unless it indicates the

student is unable to attend class. Schedule your routine medical appointments at times that do not conflict with class time.

- Family emergency. Serious illness or death of an immediate family member. Documentation of this emergency must be provided.
- Participation in a university sponsored activity. Permission for an excused absence must be obtained in advance of the activity and the student must have a letter from the faculty sponsor indicating the student's involvement in the activity.
- Assignments due during a time that a student is participating in a student activity must be emailed to the instructor prior to departure or immediately upon the student's return, with the instructor's permission. Assignments due during a time when a student is excused for other reasons will be due at the beginning of the second class following the student's return unless other arrangements are made with the instructor.

## **BEHAVIOUR POLICY**

You are expected to have good behavior throughout your online interaction with classmates/instructor. Any offense after the first warning will result in a 5-points penalty per occasion. Good behavior includes but is not limited to: not being late in your replies, participating with a good attitude, not using F-words, etc. Pay attention to using capital letters in your interaction as it might be interpreted as inappropriate.

## **Emergency Procedures**
