## **Course Description**

This course is an introduction to the field of UX/UI design. The course aims to provide students with the knowledge and skills needed for designing user experience and interaction. The course also will allow students to acquire skills in market-standard UX/UI tools such as Adobe XD, and Figma.

### **Course Objectives**

By the end of this course, you will be able to:

- 1. know what design is and what it involves.
- 2. identify principles of visual design in UI.
- 3. identify typography of UI design.
- 4. determine different design systems.
- 5. know the psychology of colors in UI design.
- 6. gain skills in using UI/UX tools.
- 7. gain skills in wireframing, mockups, and prototypes.

## **Evaluation Methods and Criteria**

#### Weekly Discussions (10X10)

Discussions in this course aim to provide you with a channel to communicate with your classmate. It also is a way to reflect on the knowledge you gain. The discussion will start on Mondays and will be due on Friday at 11:55 pm. You will need to interact with your classmates and do at least two replies to get the full points of the discussion.

#### Weekly Activities (10 X 30)

Activities aim to evaluate your knowledge acquisition during this class. Activities might be a reflection you write about a specific area in the field, a mini-project you do with the tools provided, or a group project between 4-5 classmates. The activity statement starts will be posted on Mondays and will be due on Friday.

#### **Reflections (3X20)**

Reflections aim to make sure you are doing good during the class. From the reflections, I will have an insight into what you like and dislike, what your areas of strength and weakness are, what concerns you in this class, and what you like to know more about the field. Reflections will be at the beginning, middle, and end of the semester. Details about writing the reflection will be forthcoming.

The final project will include most of the skills learned during the semester. Instructions on the final project will be posted around the middle of the semester.

# Attendance and Excused Absences Policy

All students are expected to read/watch/listen to all the posted materials. This is mandatory. Students are permitted a maximum of two unexcused absences. Missing a module will result in the loss of 10 points from the student's final grade. You are expected to complete the online readings on time and submit assignments by their due dates. As for the excused absence, you should email a written excuse to your instructor to be considered excused. Not all excuses will be accepted. Acceptable excuses will be determined by the instructor according to the situation. Circumstances that will grant an excused absence are shown below. If the excuse is accepted, the student is still expected to complete their readings/ assignments when they are back from the excused absence.

Late assignments are also unacceptable. A late assignment without an excuse will lead to a zero grade on the assignment. However, submission on time and resubmission after getting the instructor's feedback is allowed and can result in regaining some lost points of the original submission.

### Circumstances that grant excused absences:

- Illness that prevents online attendance. The student must have documentation from the health center or another physician that indicates the student cannot or should not attend class. Health center documentation is not acceptable unless it indicates the student is unable to attend class. Schedule your routine medical appointments at times that do not conflict with class time.
- Family emergency. Serious illness or death of an immediate family member. Documentation of this emergency must be provided.
- Participation in a university-sponsored activity. Permission for an excused absence must be obtained in advance of the activity and the student must have a letter from the faculty sponsor indicating the student's involvement in the activity.
- Assignments due during a time that a student is participating in a student activity must be emailed to the instructor prior to departure or immediately upon the student's return, with the instructor's permission. Assignments due during a time when a student is excused for other reasons will be due at the beginning of the second class following the student's return unless other arrangements are made with the instructor.

#### **BEHAVIOUR POLICY**

You are expected to have good behavior throughout your online interaction with classmates/instructors. Any offense after the first warning will result in a 5-points penalty per occasion. Good behavior includes but is not limited to: not being late in your replies, participating with a good attitude, not using F-words, etc. Pay attention to using capital letters in your interaction as it might be interpreted as inappropriate.

I also encourage you to send me your draft versions of any assigned project to get my feedback during the process of making the assignment. This habit will result in higher quality, and bonus points for the creative ones. Please don't forget to include your name, and the class you are in in your email.

#### **Emergency Procedures**
