Students entering with an M.A. or M.S. will normally have their thesis work accepted if it was an empirical or research thesis. If the M.A./M.S. degree was completed without a thesis, a thesis equivalent project will be required. Students admitted with a master's degree are responsible for all the coursework of the Combined Program. Decisions regarding what courses (including practica) may be waived or transferred are made on a case-by-case basis. Students entering with a strong applied master's degree may expect to reduce their completion time by one year.
